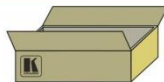


## PT-1C Quick Start Guide

This guide helps you install and use your product for the first time. ### Step 1: Check what's in the box

- PT-1C EDID Processor     4 Rubber feet     1 Quick Start sheet



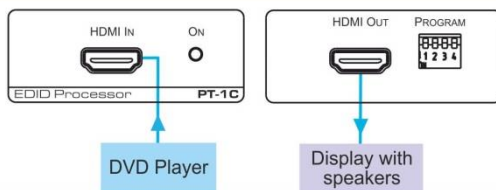
Save the original box and packaging materials in case you need to return your **PT-1C** for service.

### Step 2: Install the PT-1C

Attach the rubber feet and place on a table or mount the **PT-1C** in a rack (using an optional RK-4PT rack mount).

### Step 3: Connect the inputs and outputs

Always switch off the power on each device before connecting it to your **PT-1C**.



The **PT-1C** takes power from the HDMI interface.

Always use Kramer high-performance cables for connecting AV equipment to the **PT-1C**.

### Step 4: Operate the PT-1C

Set the program DIP-switches:

DIP	FUNCTION	DOWN	UP
1	LOCK/MODIFY	PASS EDID	LOCK/MODIFY
2	COLOR DEPTH*	PASS	LIMIT COLOR DEPTH
3	AUDIO*	PASS	LIMIT TO 2-CH LPCM
4	HDCP	PASS	HDCP OFF

\* Color depth and audio status are activated only when lock/modify is UP.

## 2 Getting Started

We recommend that you:

### 2.1 Achieving the Best Performance

To achieve the best performance:

- Use only good quality connection cables to avoid interference, deterioration in signal quality due to poor matching, and elevated noise levels (often associated with low quality cables)
- Do not secure the cables in tight bundles or roll the slack into tight coils
- Avoid interference from neighboring electrical appliances that may adversely influence signal quality
- Position your Kramer **PT-1C** away from moisture, excessive sunlight and dust



This equipment is to be used only inside a building. It may only be connected to other equipment that is installed inside a building.

## 2.2 Recycling Kramer Products

## 3 Overview

The **PT-1C** is an EDID processor for HDMI signals. It allows you to pass or block HDCP, deep audio or deep color signals that may or may not be compatible with the display.

The **PT-1C** features:

- A maximum data rate of 17.82Gbps (5.94Gbps per data channel)
- Maximum resolution of Up to 4K@60Hz (4:4:4) UHD
- Compliance to HDMI and HDCP 2.2 standards
- HDMI input and output connectors
- Power taken from the HDMI line; no power supply is needed
- A power LED that indicates power to the unit
- Four program DIP-switches that control the desired functions
- The ultra-compact PicoTools case that allows four units to be mounted side-by-side in a 1U rack space with the optional RK-4PT 19" rack adapter

### 3.1 Defining the PT-1C EDID Processor

This section defines the **PT-1C**.

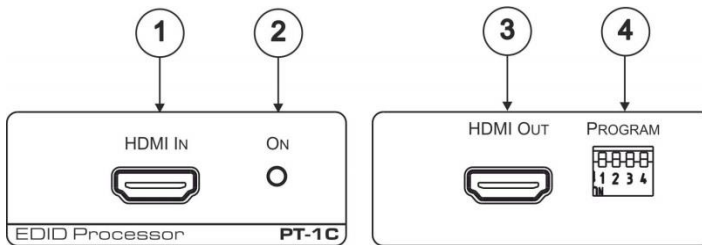


Figure 1: PT-1C EDID Processor

#	Feature	Function
1	HDMI IN Connector	Connects to an HDMI source
2	ON LED	Lights when an HDMI source and acceptor are connected
3	HDMI OUT Connector	Connects to an HDMI acceptor
4	PROGRAM DIP-Switches	Set switches to choose an EDID

## 4 Connecting the PT-1C



Always switch off the power to each device before connecting it to your **PT-1C**. After connecting your **PT-1C**, switch on the power to each device.

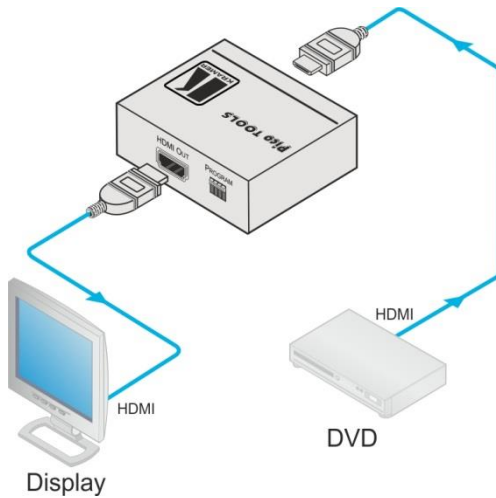


Figure 2: Connecting the PT-1C EDID Processor

To connect the **PT-1C** as illustrated in the example in [Figure 2](#):

1. Connect the HDMI source (for example, a DVD player) to the HDMI IN connector.
2. Connect the HDMI OUT connector to an HDMI acceptor (for example, a display).

## 4.1 Setting the DIP-Switches

Set the DIP-switches to control the following functions:

- DIP 1 passes the EDID or locks the entire EDID file of the connected display at the time of the locking action (with the relevant changes done by DIP 2 and 3).  
**DOWN** = passes EDID  
**Switching UP** = locks the EDID of the currently connected display (with modification according to DIP 2 and DIP 3)  
**UP** = uses the locked EDID file (ignore the EDID of the currently connected display)
- DIP 2 controls deep color:  
**DOWN** = passes the deep color EDID parameter (set DIP 1 ON to activate state)  
**UP** = limits the color depth to 8-bits per color
- DIP 3 controls audio:  
**DOWN** = passes the audio EDID parameter (set DIP 1 ON to activate state)  
**UP** = limits the audio to 2-channel LPCM (linear pulse code modulation)
- DIP 4 controls HDCP:  
**DOWN** = passes HDCP  
**UP** = HDCP off



**Note:** Color depth and audio status are activated only when lock/modify is up.
